## Message from the President



It gives me great pleasure to give a foreword message in this inaugural issue of MAHO's newsletter - in touch ... I wish to take this opportunity to congratulate the Secretariat for finally making MAHO newsletter a reality and is expected to be in circulation at least twice a year. It is hoped the newsletter will serve to inform members of its activities and the industry relevant information.

MAHO has gone a long way from the time it was established in March 1998. It has now 39 members, corporate companies which own more than 150 hotels (mainly 3 to 5 star) in Malaysia representing more than 58% of

the total 3 to 5 star hotels in the country. New members are being pursued aggresively especially those outside the Klang Valley so that the membership and its strength is consistent and reflective of the importance of the hotel sector in the progressive, fast changing and challenging tourism industry in which the hotels are one of, if not the key players. Moreover, most importantly, MAHO has now established itself prominently with the industry authorities e.g. the Ministry of Culture, Arts & Tourism, Tourism Malaysia and other government bodies such as the Ministry of Finance and the Prime Minister's Department. MAHO now sits in several working committees for various projects and activities, and being invited to meetings with the authorities concerning the tourism industry in particular.

Needles to say, that with MAHO's active involvement and participation, through MAHO, the voice of the hotel owners are being sought of and heard by the concerned authorities. However, we are still not pleased with our achievements so far. There are still a number of important issues such as the reinvestment allowance and electricity industrial tariff for the hotel sector still have not been given due consideration by the government and the relevant authorities. Nevertheless, we will keep on pursuing the issues tirelessly until we succeed. For that to happen, the Secretariat is leaving no stone unturned and most importantly, co-operation and support from members are vital for which I sincerely hope and look forward to receiving continuously from you all.

In conclusion, I thank you for all your past support and co-operation and take this opportunity to wish everyone Selamat Hari Raya Aidil Fitri, Merry X'mas and a Happy New Year 2003.

MAHO is also a networking platform for hotel owners in the country.

## MEMBERSHIP U p d a t e




## **MAHO 5th Annual General Meeting**



## INDUSTRY **NEWS**

Hotel Stock Report (Source: NAPIC)

In Quarter 2 (Q2) 2002, a total of 130,617 rooms were available in Malaysia representing 1,926 hotels compared to 129,925 rooms within 1,929 hotels in Q1 2002. In Q2, 4 hotels consisting of 843 rooms were completed. The national average occupancy rate of 3 to 5 star hotels rose from 53.0% in Q1 2002 to 56.1% in Q2 in tandem with the increase in tourist arrivals to 21.1% from 2,778,698 to 3,531,896 in Q2 2002.

Tourist arrivals January-August 2002 (Source: Tourism Malaysia)

From January to August 2002, Malaysia recorded tourist arrivals of 8,931,774, a drop of 6.1% versus previous year same period. However, on month to month basis, March arrivals managed to hit more than one million with May, July and August arrivals exceeding the previous year's figures:




## What's up...?

The Secretariat has taken up the issues below and following up with the relevant authorities and parties:

- Room Rates review/revision. Still at discussion stage and looking at suitable options for the exercise. NEAC and MOCAT have noted the issue of Malaysia hotels having the lowest room rates in the region and the need for a revision.
- Music Royalty with MACP and PPM. Looking at the rates and areas for cost savings. At the same time considering an alternative for music source provider at cheaper rates.
- 3. **Astro charges** met and discussed with Astro on the possibility of lower rates or better packages.
- 4. Electricity Tariff and Industrial Category (TNB) met with TNB to discuss the issue.
- Assessments DBKL and other local authorities (MPPJ, MPSJ, MPSA) - requesting to study the formula and rates charged. To pursue at higher levels of relevant authorities.
- Energy efficiency (EE) programmes organizing a briefing to members by The Energy Commission (EC), Pusat Tenaga Malaysia (PTM) and Tenaga Nasional Berhad (TNB).
- 7. Reinvestment allowance pursued matter with Ministry Of Finance for 2002 and 2003 National Budgets. Regrettably, discussions did not yield any positive response.
